Current Reporting Year

Scope 1

Scope 1 is reported as 0 tCO₂e in 2022 due to Ansarada having no boilers, on-site manufacturing, a fleet or f-gases to report emissions on.

Scope 2

Within Scope 2, we have included emissions resulting from the consumption of purchased electricity and working from home. As all employees utilise hybrid working, we have calculated 3 out of 5 days spent working from home each week.

Scope 3

We are currently looking to track our upstream and downstream transportation and distribution in more detail, however, we currently don't have all these figures available. Consequently, the downstream transportation and distribution subset in Scope 3 is reported as 0tCO₂e 2022. Due to this, we are looking at our supply chain to ensure all mileage is tracked. Once the data is available, we will re-baseline to ensure our carbon emissions can be compared fairly year on year.

Emissions reduction targets

In order to continue our progress to achieving Net Zero, we have adopted the following carbon reduction targets.

We project that carbon emissions will decrease over the next five years to 87.5tCO₂e by 2027. This is a reduction of 11%

Carbon Reduction Projects

In order to reach our 11% reduction target over the next 5 years, we will be:

- Ensuring all office lighting is LED, with light sensors in every room to reduce unnecessary consumption;
- Carry out a needs assessment for all in-person meetings to ensure we meet virtually where possible;
- Sign-post recycling bins to educate employees on sustainable waste and support them in being environmentally aware
